Subject: Waste Control Specialists LLC's Physical Security Plan, Guard Training and Qualification Plan, and Safeguard Contingency Plan

Dear Mr. Lombard:

On April 28, 2016, Waste Control Specialists LLC (WCS) filed its specific license application (Reference 2) requesting authorization to construct and operate a Consolidated Interim Storage Facility (CISF) for Spent Nuclear Fuel (SNF) and Reactor-Related Greater Than Class C Low-Level Waste (referred to henceforth as SNF) in Andrews County, Texas.

WCS requested authorization to possess 5,000 Metric Tons of Uranium (MTU) for dry-cask storage of SNF for duration of 40 years.

In its referenced license application, WCS committed to submit its Physical Security Plan, Guard Training and Qualification Plan, and Safeguard Contingency Plan, under separate cover, due to the sensitive nature of information contained in these documents. Accordingly, WCS hereby submits the subject documents as part of its referenced license application as specified in 10 CFR 72.24(o), 72.180, and 72.184, respectively.





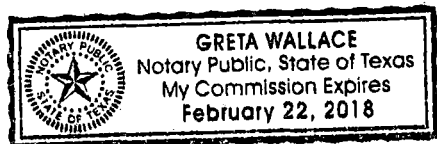
